Dean's Ordinance,

on the verification of study obligations fulfilment in the academic year 2020/2021

Article 1

Introductory provisions

- 1. The fulfilment of study obligations is governed in particular by the provisions of the Study and Examination Code of the University of South Bohemia in České Budějovice (hereinafter referred to as the SEC)
- 2. The Dean's Ordinance is based on the Rector's Ordinance R 423 of March 24, 2020, on the extraordinary ordinance concerning studies in spring semester 2019/2020 and sets out specific conditions for the verification of studies at the Faculty of Agriculture of the University of South Bohemia.

Article 2

Verification of fulfilment of study obligations

- 1. Verification of the fulfilment of the obligation to obtain 20 credits for the first semester of study for firstyear bachelor's and follow-up master's degree students (Art. 24 paras. 2 SEC) will be performed in accordance with the schedule of the academic year 2020/2021 as of 26. 3. 2021
- 2. Verification of the fulfilment of the obligation to obtain 40 credits for the first two semesters for first-year bachelor's and master's degree students (Article 31, paragraph 1, letter b, SEC) will be performed in accordance with the schedule of the academic year 2020/2021 as of 31. 8. 2021.
- Verification of the fulfilment of the obligation to obtain 80 credits for four consecutive semesters for students of the 2nd year of bachelor's and subsequent masters study (Article 31, paragraph 1, letter c, SEC) will be performed in accordance with the schedule of the academic year 2020/2021 as of 31. 8. 2021. Students in follow-up master's studies are obliged to obtain at least 80 credits for the last consecutive 4 semesters only on the condition that they do not register for the final state examination.
- 4. Verification of 80 credits for four consecutive semesters for students of third and higher years of bachelor's study (Article 31, paragraph 1, letter C of the SEC) will be performed according to the schedule of the academic year 2020/2021 as of 31. 8. 2021. Students in bachelor's degree studies are required to obtain a minimum of 80 credits for the last consecutive 4 semesters only on the condition that they do not register for the final state examination.
- 5. With regards to the epidemic situation, students were informed about the postponement of the dates of study verification for the summer semester 2019/2020 through the above-mentioned Rector's Ordinance R 423.
